Herewith information on the **Global Health European Developing Countries Clinical Trials Partnership (EDCTP3)** opportunities for 2026. The attached Work Programme (WP) includes calls for proposals covering 6 topics, for a total indicative budget of EUR 147 million. The calls will support 4 **Research and Innovation Actions (RIA)** topics aimed at developing new or improved TB drugs, supporting the prevention and management of lower respiratory tract infections, ensuring better prevention, treatment and management of HIV and its co-infections and co-morbidities, and addressing the global challenge of climate and health. Additionally, 2 **Coordination and Support Actions (CSA)** topics will support training and capacity-building activities in the areas of ethics, regulatory and pharmacovigilance, and enhance integrated research and healthcare through digital innovation and artificial intelligence.

How to apply: The calls for proposals will open for submission by **mid-January 2026**. Applications must be completed through the European Commission's [Funding and Tender opportunities portal](#). Please refer to the [EDCTP3 website](#) for more information.

Deadlines: RIAs two-stage calls – first stage **4 March 2026** and second stage **17 September 2026**. CSAs single-stage calls – **31 August 2026**.

Consortium composition: Legal entities forming a consortium are eligible to participate provided that the following conditions are met (applies to both RIA and CSA calls. Please see pg 58 – 59 of the attached WP for the specific rules):

- At least three legal entities independent from each other and established in different countries, where legal entities are eligible to receive funding
- At least one independent legal entity established in a Member State or an associated country
- At least one independent legal entity established in a sub-Saharan African (SSA) country that is a member of the EDCTP Association
